3. 196/18 BUDGET PLANNING

The meeting was held in order to begin talks regarding the next financial year. A draft budget was circulated (see appendix 1) and this formed the basis of the discussions regarding next year's budget.

In addition, there was a discussion regarding saving money and it was suggested that savings might be made by having timers on the streetlights.

There was also a discussion regarding the costs of transferring the Community streetlights to FCC and it was agreed that in setting the precept, one light per year should be included.

It was also agreed that, in Gwaenysgor, the purchase of the village signs and plaque be deferred until a later date and it was suggested that AONB be approached for financial support.

It was suggested that FCC be contacted regarding the contract for lighting inspections.

7-8 Bron Haul. This light has been out of action for some time and it now appears that it is an issue for Scottish Power as it concerns a problem with the power to the unit.

Light outside the Crown Inn – this is now a serious problem and a potential danger. Cllr David Ellis said he would investigate the way forward with this.

Broken light outside Gwaenysgor Village Hall. The Clerk had contacted the insurers who requested a photo of the damage and the date of the incident. Cllr Peter Jones has provided this information.

• Trelawnyd Memorial Hall

There had been talks regarding placing a covenant on the Hall in order to preserve from being sold in the future. The Council decided that this is not an urgent matter at the moment but that a watching brief for the potential merger of councils be kept.

Cllr David Ellis to make enquiries and to keep the Council informed of any developments.

• Path Extension – Crown Inn

It was agreed that quotes now need to be procured for this work. It was also agreed that the work be deferred until the 2019/20 precept period.

• Councillors' Expenses

It is not mandatory to accept the expenses but it is important that there is provision should it be required. The Clerk, therefore, will circulate a form which will enable Councillors to state whether they require the expenses.
